There are many ways to communicate electronically with people these days, keeping a safe distance. This article explores ways to communicate with lots of people at the same time.


By Email



You can create a group of contacts in your email program. Then you can create and send a message to that group and they will all get your message.

Use the BCC (Blind Carbon Copy) line for the group so that all the email addresses aren't visible to everyone. This protects the privacy of the recipients.

By Phone




Did you know that you can set up a conference call with all your friends and family for free?

[Freeconferencecall.com](https://www.freeconferencecall.com) is a free service that allows an unlimited number of people to call a phone number, enter an access code, and talk with all the other people on the line. The phone number to call isn't local, so long-distance charges may apply. However, most people have unlimited long distance for calls within the US these days.

Freeconferencecall.com also offers free screen sharing and video conferences. [Compare their services to others on their website \(scroll down to see the chart\).](#)

By Video



There are many options for face-to-face communication using video. Your computer or device would need to have a camera.

In addition to [freeconferencecall.com](https://www.freeconferencecall.com), noted above for audio meetings, there are also these other apps that are free (or very low-cost).

[Zoom](#) is a popular video conference application. The free version allows for unlimited 1 to 1 meetings, 40-minute sessions for 3 or more people, application sharing, and collaboration. [Click to read about all their offerings.](#) They are offering added support and training during the pandemic. [Click for more information.](#)

[Skype](#) is a free video communication tool that you can use to connect to other people who have Skype accounts. Software downloads are available for Windows, Mac, and Linus desktops and Apple and Android mobile devices. [Click for a list of features.](#) Skype also offers free video conferences and conference calls that anyone can join even if they don't have a Skype account; no special software is required. [Read more about this feature.](#) (Skype is a product of Microsoft.)

CAMUG June 2020 Meeting Minutes

The meeting was held on Zoom due to COVID-19 restrictions. Judy Taylour from APCUG set up the meeting using an APCUG account and Dennis Smith was the host. Members received an email invitation before the meeting and used that to connect to our Zoom waiting room. They were then admitted to the meeting. The meeting opened about 6 PM.

6 PM Discussion: Free OFFICE.COM by Carol Joliat, Jan Bredon, and Dennis Smith

- Carol shared her screen and compared the various versions of Office with the free version available at office.com. Office online is a free version that you can use in a web browser. You must have a Microsoft account and login and your files will be saved on OneDrive automatically.*
- Carol compared the ribbon for Word 2013 and ribbon for the free online version. There are almost the same except the Dictation button is missing from Word 2013.*
- The ribbons for Excel 2013 and PowerPoint 2013 and the free versions are very similar also.*
- Dennis described how he created the agenda for the meeting using the free version. He first uploaded last month's agenda to OneDrive and then edited it in the free version. The table showing CAMUG officers needed quite a bit of tweaking, but the rest was relatively easy.*
- Jan mentioned that office.com has some free templates and others to buy.*
- Jan said when he tried to do a "save as", he went back and then forward again but his information was still there because it is saved automatically to OneDrive. He uses office.com on his Chromebook.*
- Dennis mentioned that office.com is similar to Google Docs and Jan said that Google Docs resides on the machine while office.com is in the cloud.*

Other discussion;

- The group discussed the difference between Zoom, Google Duo, and Microsoft TeamViewer.*
- Dennis asked how many are using the new version of the Microsoft Edge browser based on Chrome. Many have downloaded it, but few use it extensively.*
- Dennis gets a free newsletter called Ask Woody which was formerly Windows Secrets. A recent issue discussed the Windows 10 2004 Update and concluded*

that there are problems and it may be wise to wait a while before installing the update.

- *Carol asked about the life of a Chromebook; she got a message that her Chromebook is expiring even though it still works. Jan said the life is 6.5 years from the date the version comes out.*
- *Cherie had a problem with a video from her Facebook page. She put a link to that video in an email and sent it out. Anyone who clicked on that link had access to her Facebook account and could act as her. Suggestions from CAMUG viewers included changing her password.*
- *Jan had a couple of video cameras that are no longer supported, but he found Wyse cameras at both Chewy.com and wyze.com that are about \$25 each, can have an added SD card for about \$10, can take photos continuously or when sensing motion, and be accessed over the internet. They are indoor cameras but can be positioned to shoot out a window.*
- *Gerald Schaefer has a friend with a Revo camera system of 6 cameras which he likes.*

Regular Meeting



President Dennis Smith called the 441st meeting of CAMUG to order at 7:00 PM on Monday June 15, 2020, using Zoom. There were 14 members present representing 13 member families. Since that is more than 15% of the membership, the meeting was declared valid. Cheryl Krantz was a visitor and Judy Taylour from APCUG was a visitor and our speaker. Judy is Chair of the APCUG Board of Advisors, Chair of the VTC committee, Chair of the Push Committee, and many other committees.

Dennis mentioned that members receive a \$5 renewal credit for each new member they bring in.

Program: Digital Asset Estate Planning: Even After You've Died, Your Identity Isn't Safe, by Judy Taylour.

- Your digital assets consist of your technology equipment and also all your accounts and information.
- It is very important to have a Digital Executor to handle these things after you die and to manage your digital assets to protect your privacy and your identity. Your Digital Executor may be the same person as your regular Executor or it may be a different person. Your digital information is very vulnerable to identity theft in the year after your death.

- Judy suggests limiting information in your obituary. For instance, put your age instead of your birth date. Personal information in an obituary can be used by someone to steal your identity.
 - It is critical that your Digital Executor be able to access your data. Start by making a list of all of your accounts, logins, passwords, automatic payments, etc. Delete accounts you no longer use to make it easier for your Digital Executor.
 - Go through your old photos. Add identifying information on the back, scan and add identifying information, and get rid of unknown photos to make it easier for your Digital Executor.
 - Have a beneficiary for your DNA results.
 - Don't put logins and passwords in a will because a will is a public document. A trust is not public so it could include this information. An alternative is to tell the Digital Executor where the information is kept.
 - There are several ways to keep this information. This can be a password program, a list on an encrypted flash drive, an encrypted file on a computer, or a list in a notebook.
 - Some password programs are Dashlane (\$60 per year), Last Pass (free or \$3.00 a month), and RoboForm (\$39.95 a year).
 - Your Digital Executor needs access to the phone or email account where verification information is sent. This phone or email account should be the last to be closed.
 - If your equipment uses fingerprint access, have an alternate method for access.
 - Keep all the information up to date.
 - Everplans.com can store digital archives online.
 - Get a social security account with login and password to guard against identity theft.
 - Also get an IRS username and password for the same reason.
 - Deleting accounts by using the username and password is MUCH easier than doing it by mail. Judy showed the steps required for several common accounts. This is another reason to give your Digital Executor all your information.
 - Judy will send pdf tables and lists containing this information to Dennis so he can send it to members.


Other:

- There was discussion about how to add a virtual background in Zoom. Judy gave directions and several people experimented.
- Judy mentioned that the latest version of Zoom is 5.0.5. Download updates at <https://zoom.us/download>.
- Alice uses Spectrum email and tries to send emails BCC (blind carbon copy) or just to herself, and they don't appear in her Inbox but do appear in Sent folder. Dennis has the same results with Gmail.

Genealogy Research Online

Well, the Coronavirus has us isolated at home instead of at work. Some people, so I've heard, are tackling tasks they've deferred for the proverbial "rainy day." I've often said to myself that I would scan that box of photos I rescued from my departed uncle's home before its contents were sold at an estate sale. I intend to distribute the images to my relatives. The issue is ...identifying the people in the photos. Genealogical research can be a tedious task. Just such a task for a time like this. If you are

interested in creating a family tree, or simply learning more about your ancestors, there are many websites where you can conduct genealogical research. Some of these websites are interactive and allow you to share photos and communicate with distant relatives. Bob Rankin at AskBobRankin.com provides a list of useful sites for Genealogical research:

1. Ancestry.com – perhaps the best-known website for genealogical research. It is a subscription-based service that costs \$199/year or \$99 for six months. A 14-day trial will allow you to evaluate the service. For an additional fee, the “World Explorer” package adds the ability to search internationally.
2. Cyndi's List – is a free, “...categorized & cross-referenced index to genealogical resources on the Internet. Over 335,000 genealogical sites are linked from this website.
3. Family Search – is run by the LDS Church. It provides access to over a billion records worldwide at no cost. The LDS Church also provides personal assistance and access to some of the paid sites via local family history centers. A local family history center is located at 20 Boscobel Rd Fredericksburg, VA 22405 (540) 361-7494.
4. Roots Web – is the oldest and perhaps the largest genealogy site on the internet. The Roots Web site has genealogy search engines and message boards where you can obtain help from budding but more experienced genealogists.
5. USGenWeb – provides lists of genealogy resources by state and county.
6. WorldGenWeb – is similar to USGenWeb. Bob Rankin says, “WorldGenWeb is a nonprofit volunteer organization that is dedicated to the free use and access of public domain genealogical information.”

Mr. Rankin notes several other websites and the resources that are provided in the article linked above (i.e., at AskBobRankin.com). He also provides links to genealogy software.
